#### 1. Confirmation of the minutes of the last meeting

## 5. Setting up HUCMS as an independent charitable organization

Further to the discussion in the last meeting, Mr. Cheung Kwok Ying and Ms Paggie Tong presented the proposal for formation of a charitable organization under TWTSAA. The following papers were presented:

- (1) Proposal for formation of a Charitable Organization under TWTSAA;
- (2) Information required for the application and establishment of a charitable organization;
- (3) Draft Memorandum of Association of the TWTSAA Charitable Foundation;
- (4) Draft time line for establishing the Foundation

In the meeting, Mr. Stephen Chan, Cheung Kwok Ying and Ms Paggie Tong clarified the urgent need of the Foundation, the objectives, and the time to form the Foundation, and confirmed that all the cost would be borne by HUCMS. The Chairman and members in principle supported the proposal, and requested HUCMS to further detail the objectives of the Foundations and clarify the composition of the Board of Directors. Meanwhile, HUCMS would prepare the consultation paper to members according to the timeline.

Mr. Cheung Kwok Ying expressed his gratitude to Professor Cheung and Mr. Mak for their valuable advice on the proposal, and to Ms. Paggie Tong, Mesa Ho, Tenny Tam for their great assistance in formulating the proposal.

## 6. Meeting on 15 September at Yau Yat Chuen Club

A gathering and meeting was held on 15 September 2012 at YYC with members of ExCom and HUCMS. The Chairman reported that a subsequent meeting with the Mr. Lee Tak-wing, the Chairman of 有定堂 was held on 29 September 2012. Mr. Lee would like to receive progress report from HUCMS. Mr. Cheung Kwok-ying would follow up with Mr. Lee, and he would e-mail the latest HUCMS progress report to him.

## 7. Report from Recreation and Publication/IT subcommittees

The target for distributing the next publication of 荃情 would be on 5 December 2012. The deadline for submission of the articles would be 21 November 2012.
